## Overview

To protect against the health risks of disturbing lead-based paint during common renovation activities such as sanding, cutting, and demolition, on April 22, 2008 EPA issued a rule under 40 CFR 745 requiring the use of lead-safe practices and other actions aimed at preventing lead poisoning. Under the rule, **beginning April 22, 2010**, contractors performing renovation, repair and painting projects that disturb lead-based paint in homes built before 1978 must be certified and must follow specific work practices to prevent lead contamination. It affects not only contractors involved in any construction activity that has the potential to disturb lead-based paint, but maintenance workers and specialty trades such as HVAC, plumbers and electricians. The rule has implications for property managers, landlords, building code officials and designers.

The training will be provided by Baker Environment Consulting, Inc., an EPA-accredited RRP training provider. Those passing a multiple choice exam with a score of 70% or better will receive a Certified Renovator certificate.
